Our home



Teaching for public leadership

The Master of Public Policy (MPP) is an intensive, oneyear graduate degree designed to provide the academic knowledge and professional skills required to address some of this century's most complex public policy challenges.

The Doctorate (DPhil) in Public Policy is a threeyear, full-time research degree with an emphasis on public policy analysis. It provides robust training for understanding particular policy problems and for evaluating, devising or implementing policy solutions.

The Executive Education courses for senior professionals and policymakers are designed in partnership with governments and specialist organisations to provide intensive training and expert insight on a range of public policy and leadership challenges.

Research for policy impact

Our wide-ranging research relies upon meeting the highest standards of academic excellence while aiming to provide the evidence, analysis and insight to address some of the most urgent problems facing governments and societies. Many of our academics are leaders in their field and regularly called upon by governments and global institutions to offer their expertise for designing effective policy solutions.

Some recent examples of research:

- The RISE Programme on improving education systems and learning outcomes for all.
- The Government Outcomes Lab (GO Lab) in partnership with the UK Cabinet Office on public sector commissioning and outcomes-based commissioning.
- Evaluating evidence around HIV interventions in sub-Saharan Africa.
- Assessing the ethical implications of lethal autonomous weapon systems (LAWS) and how governments can effectively regulate their development and deployment.
- Examining national contexts of climate actions taken by non-state actors.

Engaging to make a difference

We develop innovative and productive collaborations with governmental and non-governmental organisations, including the private sector, that help us stay connected with real-world challenges and provide pathways to impact from our research. We are also working hard to engage more donors in our mission, so that we can be sure that no student, no matter what their financial circumstances, is ever turned away because of the costs of study with us.

We run a dynamic programme of events throughout the academic year, many of which are open to the public. Ranging from major public lectures with heads of state to seminars with academics and senior practitioners to our flagship annual conference on the Challenges of Government, these events provide an important forum for knowledge exchange and networking.
